APPLICATION FOR MEMBERSHIP IS MADE UNDER THE FOLLOWING CONDITIONS

THERE ARE THREE CATEGORIES OF MEMBERSHIP OF THE ASSOCIATION AS FOLLOWS

ASSOCIATE: Applications for Associateship of the Association will be accepted from persons aged 16 years of age and over in all branches.

MEMBER: Applications for Membership of the Association will be accepted from persons aged 18 years of age and over in all branches. Alternatively, the candidate must have held the Associateship of the Association for two years and had a minimum of two years teaching experience in the branch concerned.

Candidates must have been actively engaged in teaching dancing or majorette for at least two years in the branch concerned and must furnish satisfactory proof of personal integrity and good character.

Each candidate must also satisfy the Examining Board as to his or her qualification.

FELLOW: Candidates must have held the Full Membership qualification in the branch concerned for at least two years.

GENERAL

The Application Form shall in each case be properly filled up and forwarded to the General Secretary a minimum of 14 days prior to examination date along with Entrance Fee, Examination Fee and Annual Subscription prior to Examination taking place. Applications for Fellowship examination in any of the Theatre branches must be submitted a minimum of 2 months prior to the examination date. **Any professional applicants whose application forms have not been submitted to Head Office prior to the examination day, will not be permitted to take his/her examination. This applies to all candidates, whether already current members of the B.A.T.D. or new applicants.** All application forms for membership, ASSOCIATE, MEMBER, FELLOW, must include a declaration of the applicant's date of birth.

The annual subscription for all branches becomes due on the 1st January each year irrespective of joining date.

Persons who are already members of this Association, should ensure that Annual subscriptions are fully paid up at time of application for a Professional Examination.

Candidates for membership will not be eligible if they belong to any other Associations than those recognised by the B.A.T.D.

An Associate, Member or Fellow of any Branch of the Association must not enter or be entered for Amateur Test or Student Grade Examinations of another Branch of Dancing or Majorette.

A professional Candidate failing to attain the required standard in an Examination will NOT be allowed to re sit the Examination until 6 months elapses.

Candidates for the Scottish National branch of the Association will only be accepted from Associates, Members or Fellows of the Association's Highland Branch.

A Professional candidate is responsible for the Examiners travelling expenses and/or hall rent for the examination unless the professional examination is being taken in conjunction with amateur tests. Subject to test conditions. (Expenses to be paid direct to the Examiner on the day).

Effective 1st January 2017, members wishing to enter students for B.A.T.D. Majorette examinations must hold a qualification in the B.A.T.D. Majorette branch.

Effective 1st January 2017, non-members who hold a qualification with another recognised association can only enter students for B.A.T.D. examinations in branches in which they hold a qualification with their own Association.
